MINUTES BOARD OF FIRE COMMISSIONERS Public Hearing – 2022 Proposed Budget October 19, 2021 – 7pm – Station 2

At 7:01 pm, Chairman Komorsky called the Board of Fire Commissioners' Public Hearing on the Budget to order for Tuesday, October 19th, 2021, and led the Pledge of Allegiance. He thanked everyone for attending.

- BUDGET DISCUSSION:

Komorsky read a notice on the budget hearing that noted when and where notice of the hearing was posted (affidavit attached). Treasurer Mark Pozniak reviewed the proposed budget (attached) but noted that there were currently negotiations happening that may affect the proposed budget. He went through projected increases for an individual homeowner over the next few years.

PUBLIC COMMENTS:

At 7:28 Komorsky opened the hearing for public comments and reviewed the procedure for an individual to make comments.

Joseph Luna: "The question I have is the intent to hire more people with or without the grant?"
 Pozniak said that the budget includes nine new hires and the grant and the Board would have to answer that question. Komorsky said it comes down to accepting the grant or not accepting the grant.

Commissioner Pignataro said that if anyone attending via Zoom had any questions at this time they could ask the Board directly then he would read the comments submitted via the chat feature. He then read the following messages that came via chat from Ron Schulz:

- does LaGrange participate in Length of Service Award Program (LOSAP) allowed by the state to help retain VOLUNTEERS?

Pignataro said that yes, the District does participate in LOSAP, then read the next comments.

- of the \$4.183 Million budgeted for salaries in 2022, how much of that is for expected OVERTIME?
- ...if the SAFER grant is suppose to pay for the 9 additional firefghters for the first three years, why are you
 creating a Transfer to SAFER Surplus account by appropriating an additional \$100,000 from the taxpayer
 in 2022?
- The current fire tax rate is \$4.14/\$1K valuation in 2021......Given the SAFER grant with 9 additional employees, I predict a tax rate of over \$6/\$15 valuation by 2027 at the latest...........corresponding to a \$350K (average) home in LaGrange paying over \$2100 in Fire tax alone..........Do you agree?......what would your prediction be?... and don't tell the LaGrange taxpayer that you have not or will not provide an estimate.
- \$300K house is NOT the ave in Dutchess.....much closer to 350K

Pozniak said he could address the questions. He said that the overtime number is based on the overtime that was worked this year with an adjustment up based on the consideration of two additional people per shift creating slightly more overtime. He said that he doesn't have the exact percentage, but it was something in the neighborhood of 30%. He said that the transfer to SAFER grant in the budget was to create operating surpluses in the first three years then draw down in years four through six. He said the purpose is to increase property taxes slowly over a period of six year rather than one huge hit in year four. Short discussion followed regarding the process used for projecting the overtime budget. Pozniak said that the tax rate for 2021 is 4.14 and that he thinks the tax rate at the year 2027 at the 7.875% increases would likely be around 6.30 per thousand, but in the second scenario where the increase is around 6.42%, the number would be 5.82. Pignataro said there was a follow up question from Ron Schulz and read them for the Board.

- 9 more employees but \$400K MORE OT.....are you kidding me.....absolutely UNCONSCIONABLE

Pozniak said that the 29% is a good number, but he didn't understand the second question and Sassi said it was more of a statement than a question.

At 7:28, Komorsky declared the public comments portion of the hearing closed and asked if the Commissioners had any further questions. Pozniak added that the six year plan assumes that operations are roughly the same as they are now in every other respect than the nine new firefighters.

CLOSING:

At 7:29 pm, upon a MOTION made by Sassi and SECONDED by Pignataro, the Board RESOLVED close the hearing. Burns – Aye, Piehler – Aye, Pignataro – Aye, Sassi – Aye, Komorsky – Aye. **Motion Carried**.

Komorsky stated that the public hearing regarding the 2022 proposed budget is declared closed.
