



MINUTES BOARD OF FIRE COMMISSIONERS Regular Meeting – February 11, 2025

At 6:03 PM, Chairman Marc Komorsky called the Board of Fire Commissioners Regular Meeting to order for Tuesday, February 11, 2025, and led the Pledge of Allegiance. He welcomed everyone to the meeting and thanked them for being there.

MINUTES: - 2/4/25 Special Meeting

Upon a MOTION made by Commissioner Pignataro and SECONDED by Commissioner Taft, the Board RESOLVED to approve the 2/4/25 Special Meeting Minutes. Pignataro – Aye, Ward – Aye, Taft -Aye, Tierney –Aye, Komorsky - Aye. **Motion Carried.**

CORRESPONDENCE:

- There was a check from New York State Department of Health for a CME recertification in the amount of \$300.00.

Upon a MOTION made by Commissioner Pignataro and SECONDED by Commissioner Ward, the Board RESOLVED to deposit the \$300.00 check from NYS DOH into the General Fund. Ward -Aye, Taft – Aye, Pignataro – Aye, Tierney – Aye, Komorsky - Aye. **Motion Carried.**

ROOM USE REQUESTS:

- There was were none at this time.

OLD BUSINESS/UNRESOLVED ITEMS:

Station 1 Building Update – Commissioner Ward stated he and Secretary Le talked about potentially setting up a meeting for February 20 as the 45 day window for the bid lock-in price is February 23. It will be set up as a special meeting. If they get the extensions they are looking for, then they will cancel it. If not, they will move forward based on Treasurer Pozniak's recommendations from last week. That would be the bid contract award letters. He will keep everyone in the loop. Commissioner Tierney stated they are working with various people regarding housing for the career staff. The Chief made the decision that he doesn't want anyone in the building while construction is underway. They will be getting one container to hold the materials and personal things that are there. They will also get a double wide construction trailer with four bedrooms, a table, a bathroom and a kitchenette. It needs to be approved and Commissioner Tierney needs to know when to order it because it will take a little while to get it. Commissioner Ward stated his suggestion would be that this will be a discussion item for the meeting on the 20th. Commissioner Tierney stated he will have a timeline and several things that will have to be done. Chairman Komorsky stated once they get ReFC Begular Meeting 2(111/05).

the award letters, they won't be starting the next day. Commissioner Ward stated it could take 30 days to get things moving. Commissioner Tierney stated they will need to get an external septic system set up. He is working with M & O on this. It will also need a Central Hudson hook up and an electrician to wire everything together. He has 1 price for the trailer, but there should be another coming in. He is working with the Chief on the electrician. Chief Champion stated in the Teams folder for this meeting there is a Station 1 Trailer folder, as well as one for Station 1 gutters. The quotes that Commissioner Tierney has gotten so far are in there for review. Commissioner Taft stated the information from the gutter guy is very comprehensive. Jeff asked if there was a requirement to get WIFI out to the trailers. Commissioner Tierney stated they would need TV and WIFI. Chief Champion stated they have a quote for a storage trailer for \$7,500, which is above his spending limit. If the Board would like to move forward with this, he just needs their approval. This would be to purchase a 40 foot by 8 or 10 foot wide storage trailer and is listed with a dealer right on Commerce Street. Commissioner Taft asked if they would give a better deal if they purchased two and Chief Champion stated he did not know if they had two. Chairman Komorsky asked if it was a new container. Commissioner Tierney stated it is considered a one use container and it is in perfect condition. It has two side doors. Chairman Komorsky stated he is asking because there are many used ones for much less. Commissioner Tierney stated the price he got from Wilcox was around \$200.00 a month and they are looking to rent for approximately six months. You have to pay the moving and removal fees. Commissioner Taft stated they want to make sure they get two good ones. Chairman Komorsky asked if they were for Station 2 and Chief Champion stated they would be for Station 1. The thought for now is to get a storage unit to clear out the building so they are ready for renovations and then revisit how far they want to go with building out a full storage area with a second container and roof. Chairman Komorsky stated why don't they just get both now and set it the way they want it so it's done one time. Commissioner Taft stated it would be two containers and a roof to make a breezeway in between. Commissioner Tierney asked if they needed it right away and Chief Champion said no. Commissioner Tierney stated they could order the two and get the one right away. Chairman Komorsky stated they want two matching ones.

> Upon a MOTION made by Commissioner Tierney and SECONDED by Commissioner Taft the Board RESOLVED to purchase two matching storage containers for Station 1 from Brandl's for \$7500 each. The roof issue will be discussed at a later date. Ward -Aye, Taft – Aye, Pignataro – Aye, Tierney – Aye, Komorsky - Aye. **Motion Carried.**

- <u>Station 3 Storage Room</u> Commissioner Ward stated this remains a work in progress.
- <u>Station 2 Brick Pointing</u> Commissioner Ward stated there is nothing new at this time.
- <u>Station 1 Gutters</u> Chief Champion stated in the Teams folder there is a file for the gutter quotes that have been submitted. They have three quotes to repair what is there, which comes to roughly \$4,000.00. Some of the comments from those vendors is that the repair may only last a year or two. They have gotten additional quotes to replace all the gutters, leaders, electrical tape as needed. Those quotes have come in at between \$8,000 \$10,000. His recommendation would be to replace the entire thing so it is good for 10 to 15 years at the \$8,000 quote. Commissioner Ward asked what the difference was between them and the quote from Brothers Who Do Gutters. Commissioner Tierney stated they only proposed sealing the leaks.

Upon a MOTION made by Commissioner Tierney and SECONDED by Commissioner Ward, the Board RESOLVED to approve the estimate from Chipps Seamless Gutters in the amount of \$8,000 to replace all the gutters, leaders, and electrical tape as needed. Ward -Aye, Taft – Aye, Pignataro – Aye, Tierney – Aye, Komorsky - Aye. **Motion Carried.**

- <u>Staffing Community Events</u> Chief Champion stated at this time the only update he has is regarding them getting the trailer from the Town. The Town surplused it a few meetings ago. He is coordinating with Parks Director Sandy Washburn at the Town. When she gives the greenlight, he will be contacting Brandl's and it will go up in the training area. Brandl's will check the tires before moving it.
- Operational Software Overview Chief Champion said they're getting into the thick of it with Lexipol. They are moving into policy reviews at the same time. He has been talking with Commissioner Tierney and they are looking to set up a group type event. It would be approximately a four hour session with the Commissioner, himself, the Deputy Chief, the Secretary, and any other individuals that would like to come in to go through policies and make sure they are applicable to LaGrange. They will let the attorneys at Lexipol deal with the legal wording. Chairman Komorsky asked how they are going to interface Attorney Hekle with the Lexipol attorneys. Chief Champion stated they are going to leave it with Lexipol's lawyers. They have an entire team dedicated to New York State law as it pertains to fire districts. The second software item is First Due. They have a meeting scheduled later this week and are moving forward with them. They are having some challenges with the program and data transfer aspect. They are having help from Jeff and are moving forward with it. Chairman Komorsky asked what some of the challenges were. Chief Champion stated the CAD has two different versions. One is a rip and run report which just gives you the call and the time. The second is an Excel format that gives you the narrative that the call taker takes. It gives updates as to when the equipment responds and is on the scene. It gives police information updates that might have been shared. Thanks to the County they have the ability to log into the CAD system with private access so they can see that. They're looking to mimic that with First Due, which they have access to in previous applications. Chairman Komorsky asked if it was an interfacing issue and Chief Champion said yes. They are working on it and Jeff is on top of it. Commissioner Taft asked if the one that they have now is not going to be the final product and Chief Champion said correct. Chairman Komorsky asked if after a few of these meetings, they will start to see live call data. Jeff stated he has been in contact with them and First Due finally had a call and they know what has to happen and now First Due has to bump it up to another tier to the engineer to do all of the configuration. He asked how long it was going to take and was told six weeks and reminded them that they were told it would be ready in December. He did ask if they could push to get it done sooner and has not yet heard back. Chairman Komorsky stated they are very good about paying their bills on time and they are paying for certain services and he feels it is important to have the services they are paying for. He asked what they were going to do financially to make it right. Chief Champion stated that has not been addressed yet. They have just started getting into meetings with them towards the end of January. They are still in the lower phases onboarding the program. He is not sure how long this phase normally would last for a new client. This will be one of the questions that he asks in their project meeting on Thursday morning. Chairman Komorsky asked to be informed of what that answer

was. Chief Champion stated they do have redundancy in that the staff does have access to the County's CAD system. There are alternate ways of getting the narrative. It may take a few more moments but the access is there. Chairman Komorsky stated everyone needs that.

- <u>Grant update</u> Chief Champion stated they have received final payment for the MIG Grant for the ballistic wear. He is just waiting on the bank certification of payment and then it can be closed out with the County. In regard to the SAFER Grant, since he has submitted the extension request, any additional reimbursement progress is on hold until the review of the extension request is completed. He did furnish them with financial and progress reports on time so it should not affect that aspect. They have until the end of February so he is hoping to get something in the next week or two. He has to e-mail his contact to see if there is any status update. The AED County Grant is moving forward as they have started to purchase the AEDs. He has reached out to the County and they will coordinate getting Car 8 and Car 98 to the graphics vendor so the cars can be mocked up for the graphics. Chairman Komorsky stated there are some other grants that are coming out and Chief Champion stated he has not received information on them yet. As soon as they come out, he will see what they can do.
- <u>Diesel Tank Accessories</u> Chief Champion said this is a work in progress pending warmer weather.
- <u>HIPAA Compliance</u> The Chief stated this is on hold at this time as they move forward with Lexipol.
- <u>Overhead Doors Work</u> Chief Champion stated he is still waiting to hear back from D Graphics on wrapping the doors. He does have to reach out to a few more vendors. Commissioner Tierney has to reach out to Dutchess Overhead Doors. Commissioner Tierney stated he met with the owner of Dutchess Overhead Doors on Friday. They looked at the doors at Station 1 and Station 2. He will get back to him this week with prices on the glass doors. He does recommend a steel panel on the bottom, aluminum and glass, and then a steel panel on the top. It is better for durability and wear. It will look like the ones in East Fishkill at Hopewell Hose. He found rust at this station that is coming through. Chairman Komorsky stated it has been an ongoing problem. Commissioner Tierney stated he is also trying to find a painter. One vendor said the job was too big after the walk-through. This will include power washing and painting everything. One vendor said there is a serious problem with the paint that needs to be dealt with after the gutters are fixed. Chairman Komorsky Tierney stated when they scrape it down it will create craters. He is not sure sandblasting will be different. A few of the newer panels are already rusting. The vendor said he could paint it, but it will just happen again.
- <u>Building Repairs/Repair Requests</u> Chairman Komorsky asked if anybody had anything that they had not already spoken about. Chief Champion stated he has provided a review of what has been requested for repairs over the past three months that have not been fully addressed at this time. It is for all three stations. One of the new items is that one of the larger windows at Station 1 by the rear of the engine is rattling and vibrating with a good wind. They will need to have someone come in and reseal that. Hopefully it is just loose seals and not something larger. Chairman Komorsky asked if someone reached out to Standard Glass to see if they can come down and give an

estimate. Chief Champion stated he will. Commissioner Tierney stated he has a call in regarding the bay lights at Station 2. Commissioner Ward asked if the door at Station 2 was closing and Chief Champion stated it has been looked at several times. He will get the vendor here again.

NEW BUSINESS: -

 <u>FASNY Recruitment Class interest</u> – Chairman Komorsky stated everyone has a copy of the FASNY Recruitment Class information. Commissioner Ward stated he spoke to Dan today on this topic. FASNY has agreed to come down to do a class about recruiting training. It is a two day class. According to Dan they very reputable. It helps address the recruitment and retention of volunteers. It discusses all of the activities around bringing in and motivating the volunteer contingent. He said it has been very successful. Commissioner Ward asked him about combination departments. He was told they have done this with combination departments in Maryland as well. It is something that could be of value to LaGrange. Commissioner Ward stated they would have to commit to two days of a weekend to do this. It is a hands-on class. Commissioner Ward did speak to Chief Champion about it briefly. It would be nice if there was a member here that would be interested in doing something like this. Chairman Komorsky asked if the Chief wanted to put this out to the membership to see if someone would be interested in it. Chief Champion stated he will put it out to see if there is any interest.

REPORTS: (by officers present)

- **Treasurer Pozniak** There was no report in Treasure Pozniak's absence.
- Chief Anthony Champion -
 - <u>Updates</u> Chief Champion stated Mya locksmith will be coming by Friday morning to finish changing out the cylinders on the doors here to make the entire district compatible. He has requested Lieutenant Demilto be present at the meeting on the 25th so they can discuss aspects of the apparatus repairs and the new mower. There are mechanical updates in the Teams folder for the commissioners with an update from Sean Brandt labeled as 2–11–25 update. That is the current status of apparatus as of today. They have four potential new hires that are in process for physicals and background checks. They did have three of those individuals in yesterday. One was sized today. They should be moving forward getting their information and getting gear and station wear clothing for them. They are very excited to be in the process. They are all aware that this is not an offer of employment but it is the next step in the process. Once he has the information on their physicals and background checks he will bring it to the Board. At the last meeting he spoke about a potential transfer. That has been stopped at this time. There was something on the candidate side that has held him up. Chairman Komorsky asked if they knew what that was and Chief Champion stated he did not. Lieutenant Kile has graciously scheduled in the hose pump and ladder testing for April 21 and 22nd with Waterway. They have been doing the testing for the last 10 to 15 years.
 - <u>Training</u> Lieutenant Hildenbrand has been working with Paramedic Cummings who is moving along nicely and absorbing all of the material that is being given to him. He is showing real promise. Chairman Komorsky asked how Brad was doing overall and Chief Champion stated he is doing very well and learning all of the aspects of the training role.

Chairman Komorsky asked if he was getting the necessary respect from the staff and Chief Champion stated he has not heard otherwise.

- In County Training Chief Champion is approved for Chris Cassidy and Rich Sassi to go to 0 a fire ground thermal imaging class at the Dutchess County Training Center on February 26. There are no prerequisites. At this time there has not been a request for a vehicle, but he does anticipate that there might be. He asked if the Board was all right with them taking one and the answer was yes. Chairman Komorsky asked how the lifespan of the thermal imaging cameras that he and Commissioner Ward purchased in Harrisburg was. Chief Champion stated the lifespan is going pretty well. If they get broken, they get sent out for repair. They do have a replacement amount allocated in the budget and he will look into it to see if it is needed for this year. Chairman Komorsky asked when the replacement for those was scheduled for. Chief Champion stated he would have to check. Commissioner Ward stated it is in the replacement line. Chief Champion stated they did get a couple about three months ago to add to the tankers as well as some mutual aid equipment that goes out when needed. The lifespan on the MSAs is going fairly well. Commissioner Tierney stated the cameras do get used frequently for any "smells and bells" calls because they use them to look for any heat sources. Commissioner Ward stated in the Equipment Replacement Schedule the next round has them replacing four of them in 2029. They are approximately \$8800 each.
- Out of County Training Chief Champion stated there is no out of county training at this time.
- <u>Mechanical Status Updates</u> Chief Champion stated he put the mechanical updates from Sean in the teams folder. He did receive word tonight that Beekman's primary engine is out of service so they have asked that 11 be placed on their first alarm assignments at this time. It is not an automatic thing. They do a first dispatch, then they do a 1075 dispatch to get more of their personnel. If it is a confirmed fire, they will dispatch LaGrange. Chairman Komorsky asked what the anticipated timeline for their engine being out of service was. Chief Champion stated he does not have that information at this time. He has requested that information.
- 2024 Calls Chief Champion stated he is working on the getting the information squared away to get the LOSAP information out to the volunteers.

Chief Champion stated he has five personnel items, one civil service item and one topic of a 207A nature for executive session. These may overlap some other items from other people.

- Deputy Chief of EMS Scott Merritt

• Deputy Chief Merritt stated over the last two weeks the firefighters have had some bailout training. Lieutenant Kile and Lieutenant Zittel have been taking the lead of this training. They have built a very nice prop and it is out in the garage. They are jumping out of that window and using their belay system and then moving up to the larger window to go out. They have been

doing that for the last two weeks and he would like to thank the lieutenants for putting in the work in building the prop. There have been no injuries.

A few weeks ago Dutchess County put together a supplemental ambulance service. The 0 County signed a contract with two commercial services, Empress and Ambulanz. They run two BLS ambulances and one ALS fly car just to supplement the EMS system in Dutchess County. When the mutual aid call goes out if no units are available to respond, one of those ambulances is automatically dispatched along with the town's primary mutual aid partner. Right now it is funded by the Dutchess County Legislature but going forward they do not know how long that will last. Eventually they might start asking those who use the service to start chipping in for it. So far in the last month and a half, LaGrange has had to use them once because there was a multi casualty incident on the Taconic Parkway. They called for mutual aid and none was available so that BLS service came out to give aid. Chairman Komorsky stated if they ask for any funds to let him know. His understanding is that this is a test case study for the County to see how they can expand it without charging the taxpayers in the County or hitting any district tax or costs. Chief Champion stated he and the Deputy Chief did attend an initial meeting on this in December. One of the points they put out in the aspect of payment was that if the agency is using it as a primary EMS response, they would garnish them with having them pay for it. If it is being used as a supplemental service you would not get charged. That was the initial discussions in December. Hopefully that will continue. He will advise the board if there is any change moving forward. Commissioner Taft asked if the only time they would use them is when both of their ambulances are on calls and Chief Champion said yes. Commissioner Taft asked if it happened very often and Chief Champion stated only once in the last month and a half. Deputy Chief Merritt stated they very rarely go third ambulance out. Commissioner Ward stated he pulled the stats from five years ago, which have not probably changed much, and a third call in the district was roughly 1% of the calls. It happens but it is rare. Chairman Komorsky asked what the difference between supplemental and mutual aid was. The Deputy Chief stated one is paid to provide that mutual aid service and the other is just regular mutual aid. Commissioner Tierney stated he has been approached by people commenting about ambulances waiting in the parking lot to get dispatched for calls. Chief Champion stated the County has a Facebook page stating that they are providing a service but that perception is still out there. Commissioner Pignataro asked if LaGrange would receive this service for the third call in the district. Deputy Chief Merritt stated anytime all of LaGrange's ambulances are out and they cannot get an ambulance out, County will automatically dispatches a mutual aid ambulance. This service is automatically attach to that call so if the mutual aid ambulance cannot get out this is a guarantee this other ambulance will respond into the town. Commissioner Ward stated it is not necessarily a third call in the district. It is when they run out of resources. Commissioner Pignataro stated it makes sense and it sounds like a good service. Chairman Komorsky stated this is the test case and they are working to see how it will go. Their goal is to get a County service. There are so many areas further north who do not have an ambulance service at all. Deputy Chief Merritt stated they are keeping track of it and when they use the service, he has asked the lieutenants to let him know so he can track it.

- Deputy Chief Merritt stated he submitted the controlled substance license renewal application on January 7. He is still waiting on a response from the State. They stated it normally takes two to three weeks for them to do the paperwork and they are nearing the three-week mark right now.
- The National Fire Academy puts out a program to build a QAQI System. It is to make a system from scratch and that is pretty much where they are right now. The cost of that is \$314.23 per person and he would love to send at least two people to that program so they can learn to build this program from scratch so they can adjust what they are currently doing on the EMS side. The programs are in July and August and the filing period takes place in March. The classes are July 20 and 25th or August 24th and 29th. Attendees are housed on Academy property but do have to purchase a meal ticket. Commissioner Ward asked how many he wanted to send to the QA/QI class. Deputy Chief Merritt said two but ideally he would like to send up to four. Commissioner Ward felt they should give him approval at this point.

Upon a MOTION made by Commissioner Ward and SECONDED by Commissioner Tierney the Board RESOLVED to authorize Deputy Chief Merritt to send up to four people to attend the National Fire Academy program to build a QAQI System at a cost of \$314.23 per person. Ward -Aye, Taft – Aye, Pignataro – Aye, Tierney – Aye, Komorsky - Aye. **Motion Carried.**

Deputy Chief Merritt stated he will be asking to send four people to EMS Expo. It is in Indianapolis, Indiana from October 22 through the 24th. The classes are phenomenal. There are pre-conferences and cadaver labs as well as speakers from around the world. It would be great to send people there. He is not requesting a vote on this tonight. They have not opened registration at the hotels and he does not have a price yet. Commissioner Tierney asked if there was a sign up deadline. Deputy Chief Merritt stated they have not even opened up the registration yet. He knows they have plenty of time, he just wanted to give the Board a heads up.

Deputy Chief Merritt stated he has two contractual items for executive session.

- Department Chairman Komorsky stated there was nothing to report.
- **Union** Chairman Komorsky stated no one was here from the union.

Chairman Komorsky asked Jeff Lenkowski if there were any updates on the phones. Jeff stated he had all of the information from Verizon. He needs to get with the chief to see what phone he wants. He needs to e-mail Commissioner Pignataro to see if he wants to do this now or wait until he gets back. Then he will need to speak with Commissioner Tierney, Taft, and the Chairman Komorsky to make sure everyone is on the same page. He stated Verizon has an offering for the iPhone 14, which would be free under New York State contract. Commissioner Taft's phone is not yet eligible but will be in four months. The iPhones are eligible today and the Chief's Android is eligible. It comes with a cord and a power block. They will also be getting a line of service for Deputy Chief Merritt and canceling the service lines that they had suspended for two other people. He does not find a phone line for

Commissioner Ward. Commissioner Ward stated he does not want one. Jeff asked Commissioner Pignataro if he wanted it shipped to him or if he wanted to hold off until he was back. Commissioner Pignataro stated if it was not imperative, so the he could hold off on it until he came back. Chairman Komorsky asked how information would be transferred from the old phone to the new phone and Jeff said he would work on that when they came in. He stated the only expense would be for new cases for the new phones. Chairman Komorsky asked if there were any objections and there were none. He thanked Jeff for his work on this project.

PUBLIC COMMENTS:

At 7:00 PM, Chairman Komorsky opened the meeting to public comments. There were none.

At 7:00 PM, Chairman Komorsky closed the public comment section of the meeting.

Chief Champion stated he had one item that he forgot to mention. They have spoken about the station alerting system for Station 1. He has spoken with Jeff and the Deputy Chief and they have initiated the process of looking into vendors. They did set up a meeting with Chief 360. He also briefed Jeff on the plan the Board has come up with for renovating Station 1. They are working together with a vendor to figure out what the best way would be for the wiring for ethernet and wireless for the building and any additional swipes that might need to go in. They will update the Board accordingly.

Chairman Komorsky stated when he calls Station 1 on the telephone it bounces back to Station 2. Chief Champion stated it is set up like that by default so that if the crews are out in the bays working or training it will automatically ring at Station 2 so someone is answering the phone. Chairman Komorsky asked if it does ring there and Chief Champion stated it should. He stated Station 1 and Station 3 are set up that way. He will make sure that it does ring there. It also happens that if the doorbells are hit there and no one answers, it will ring at this station. Chief Champion stated he will make sure that they are not set on the do not disturb and that they are ringing at the stations.

EXECUTIVE SESSION:

At 7:00 PM, upon a MOTION made by Commissioner Taft and SECONDED by Commissioner Ward, the Board RESOLVED to go into Executive Session to discuss five personnel issues, one civil service issue, and one 207A from Chief Champion, two contractual items from Deputy Chief Merritt, and one personnel and two contractual issues from Commissioner Ward. Pignataro – Aye, Ward – Aye, Taft – Aye, Tierney – Aye, Komorsky – Aye. **Motion Carried.**

OPEN SESSION:

At 9:25 PM, the Board resumed Open Session.

PREPARE 2/25/25 MEETING AGENDA: Secretary Le will prepare this. She said she also sent out the meeting notice for February 20. Commissioner Pignataro asked what the meeting was for. Commissioner Ward stated they have heard from two, one was verbal, and they did not hear from the third the last that he knew. He does believe they need everybody to agree to go forward.
